В. Clients' feedback on Features already built by Linedata

1. How Mfact clients voted for 2020 features

Table 1 below shows an average client interest of 61% across features released in October 2020 (up to and including Mfact release 11.5) and demonstrated on the webinar. The top 4 subjects below scored higher than 71% meaning they are most likely to meet your expectations.

With 161 CRs fixed, more than 13,000 test cases automatically run, and 200 plus man-days spent manually regression testing the final release, we have made sure that 11.5 meets the highest quality standards.

2. How Mfact Clients voted for the cloud




Figure 1: Mfact Clients Interest in Cloud

When asked about the use of the cloud, 41% of clients are currently using it in some form as shown by figure 1 below. In the next 3 years, 6% of clients plan to use the cloud with 53% having no plans to do so. The main reasons for not having adopted cloud are security concerns and cost.

We are willing to partner with clients aiming to host their environment in the cloud. Your Relationship Manager is available to start discussions around this offering.

3. Linedata Optima

When asked about Linedata Optima, 75% of clients expressed an interest in adopting it as a workflow and exception management platform leveraging the Icon database.

Optima's roadmap for 2021 contains an important milestone with the release of the **Rules' Engine**, replacing manual data collection and visual checks with automated controls that raise and handle exceptions.

Linedata will initially release around **120 Rules** for clients to use. Your relationship manager can arrange for you to receive a list of these rules and for our team to work with you to build additional rules in line with your requirements.

Linedata is also looking forward to building more web compatible screens for Mfact, allowing for direct interaction with Mfact through Optima workflows.



C. Future Mfact Roadmap

1. Linedata Mfact 2021+ Roadmap

Mfact version 11.6 is planned for release on July 31st, 2021. As you can see from the table below, the average interest is 19 percentage points higher compared to 2020 projects reaching an average of 80%.

This release will contain **New features** and continuous **enhancements** to current features as follows:

2. Linedata Data Management Service (DMS) for Mfact

During the client engagement Webinar in September 2020, we presented our new Data Management Service. This initiative will allow Mfact users to securely transfer data from different vendors to Mfact (using SFTP protocol) in a seamless and agnostic way, with Linedata as the contractual intermediary. In the survey 57% of clients expressed a strong interest in this offering, with only 8% expressing no interest at all.

Linedata is in the process of establishing partnerships with 3 market leading vendors and we plan to deliver the first release for Mfact clients by the end of 2021.
